We do not monitor your account or individual investments, unless we state otherwise in writing. We do not have any account minimums. We offer access to articles, investment news and education to help you make investment decisions, but this information is for informational and educational purposes only.</p> <p>Z-Squared is an introducing broker-dealer. Your funds and securities will be custodied by Apex Clearing Corporation (“Apex”), which services your account by: (i) executing, clearing and settling your trades; and (ii) preparing and distributing your account statements and trade confirmations.</p> <p>We offer BATS, NYSE- and NASDAQ-listed equities, ETFs, ADRs, &amp; options.
